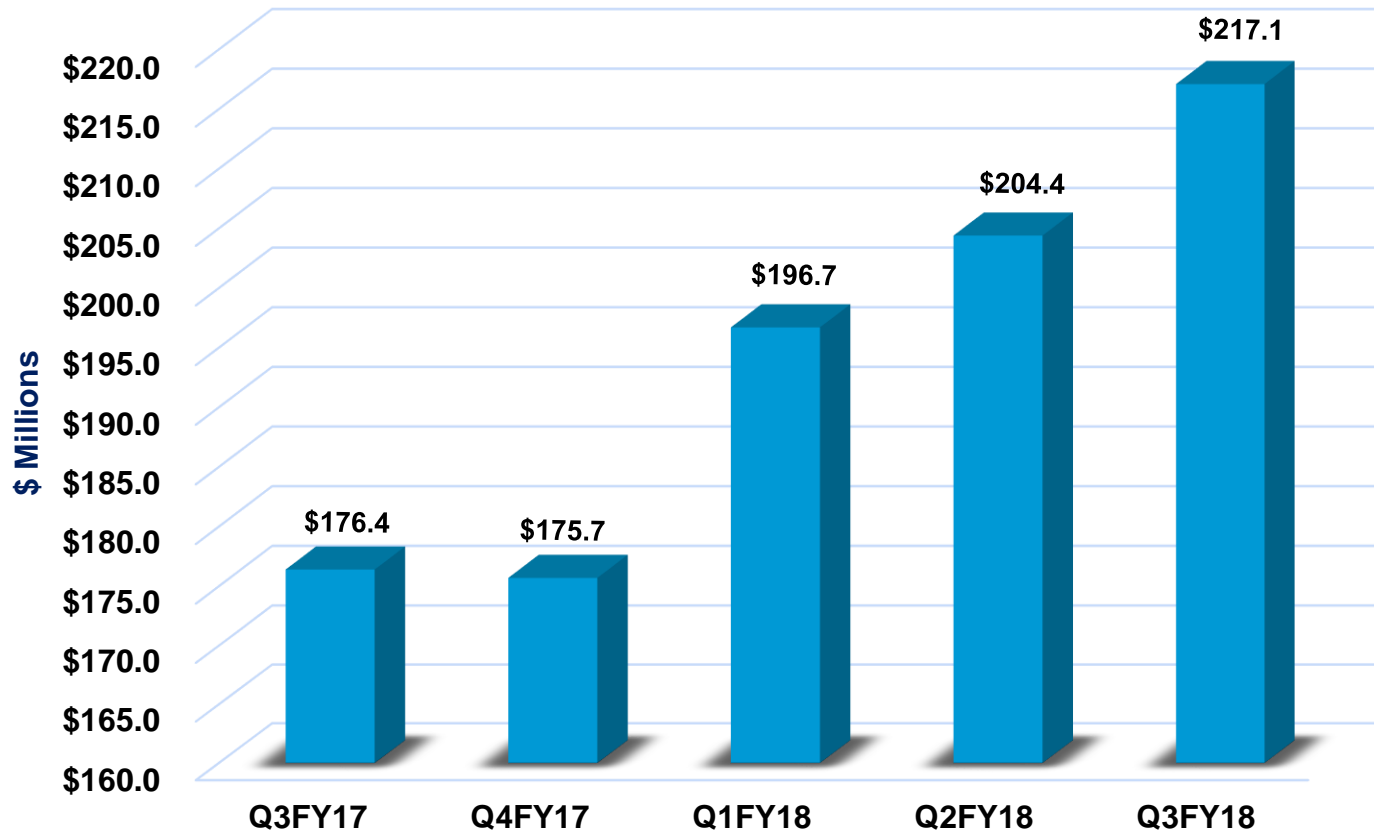

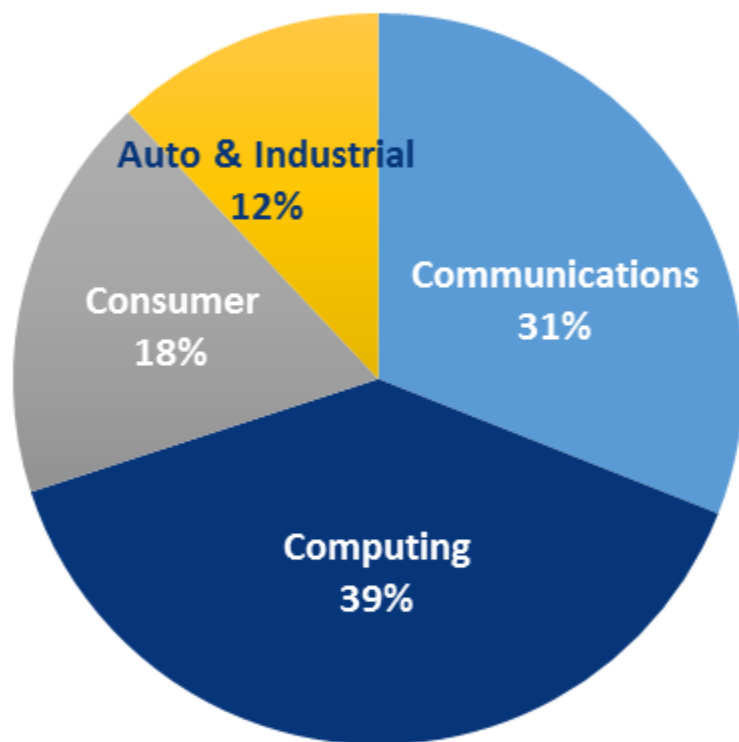

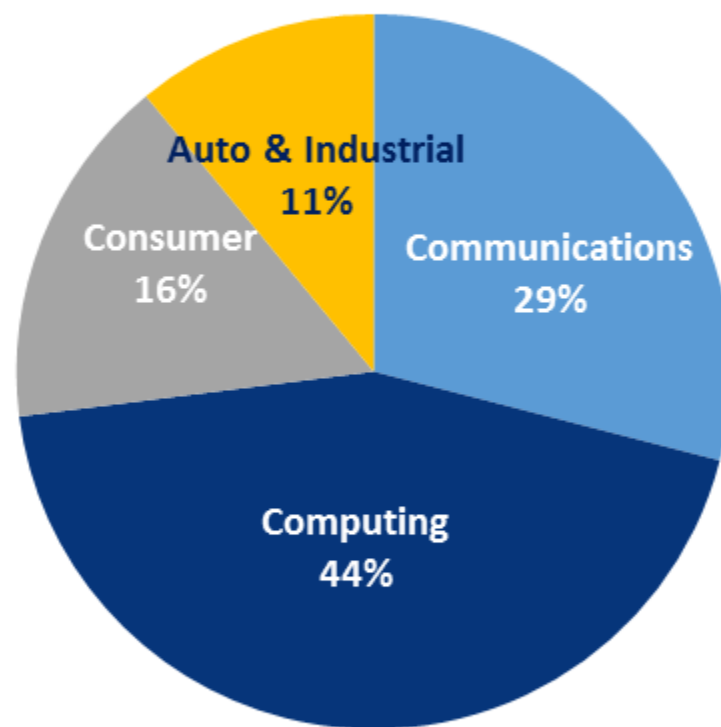

# Revenue by End Market

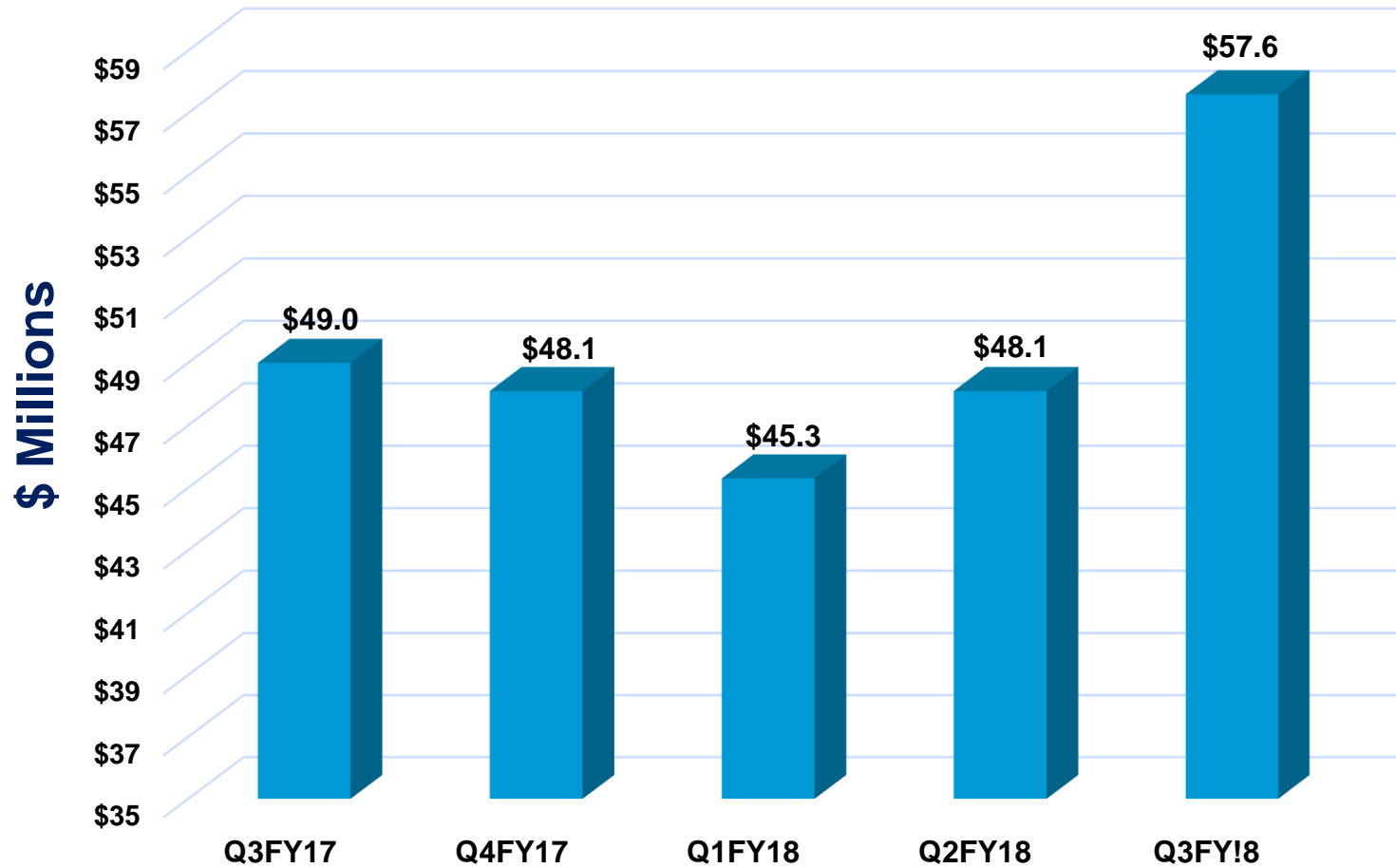


**Fiscal Q2 2018**
